

VENDOR LETTER OF DECLARATION ("VLOD")

1. PLEDGES AND UNDERTAKES THAT:

- (b) We will ensure our subsidiaries, affiliates and all other parties that we appoint to conduct work for **CMC Group** also comply with the Requirements.
- (c) We have not been convicted nor are we the subject of any investigation, inquiry or enforcement proceedings by the relevant authorities of any actual or suspected breach to the Requirements and will report any actual or suspected breach of the Requirements as soon as reasonably practicable and to the extent permitted by law, to **CMC Group**.

2. AGREES THAT:

- (a) In the event that we are in breach of any of the above, **CMC Group** may immediately revoke the contract award, or terminate the contract for the Business Transaction(s)* without any liability whatsoever on the part of **CMC Group** to the Vendor. This is without prejudice to any other rights or remedies that **CMC Group** may have or any other appropriate action which **CMC Group** may seek under the terms of the applicable tender/contract or applicable laws and regulations.
- (b) Should any person attempt to solicit any bribe or advantage (whether financial or otherwise) from the Vendor or any other person connected to the Vendor either as an inducement or incentive to be selected or as a reward, gift or bonus for being selected in the Business Transaction(s)*, or where the Vendor has reasonable grounds to suspect any breach of the obligations in this VLOD or the VCOBC, the Vendor will report such act to **CMC Group** as soon as reasonably practicable.
